Database Administrator

Milk Producers Association is the 10th largest dairy cooperative in the United States with approximately 2,000 dairy farmer members in Michigan, Indiana, Ohio and Wisconsin.

Your Mission:

To ensure the security, accuracy, and proper distribution of corporate information and to use tools and techniques necessary to manage capacity, availability, reliability, and performance of production and development databases and their environments. The role includes the creation of metrics to ensure proper service levels are attained. This person will participate on/or facilitate cross-system, cross functional teams in capacity planning, database and applications performance management, alert or availability monitoring and development of Service Level Agreements with all stakeholders and will participate in teams to set strategic database architecture direction.

Additionally, this position's responsibility will also include performing/validating database backups, recovery, reorgs, unloads, load, database monitoring/tuning, supporting production migrations, and debugging application issues for moderate to complex databases. The position will also be responsible for the day to day management and implementation of the company's database environment including, administration, change control, business continuity and support. The Database Administrator will support strategic projects by providing both database knowledge and development at an architecture level and through database coding.

Responsibilities for MMPA business include:

- Develop, implement, administer, and maintain policies and procedures for ensuring the security and integrity of the company database.
- Developing and implementing physical data models
- Develop and maintain database structures that utilize database architectural standards (normalized tables, primary keys, foreign keys, events, triggers, etc.)
- Monitors and optimizes database performance
- Communicates and monitors compliance with existing practices
- Maintains knowledge in state-of-the-art technologies and methodologies
- Ensure communication with internal staff and vendors is professional and flawless in terms of completeness and service.
- Provides work guidance and support to less experienced staff members.
- Provide guidance to developers
- Develop the design of redundant systems, policies, and procedures for disaster recovery to ensure effective availability, protection, confidentiality of data, and integrity of data assets.
- Develop methods for integrating unique, complex databases and customizing corporate databases to fit specific needs

- Responsible for the performance, integrity and security of corporate databases
- Ensure quality data creation, presentation, and data flow within our systems
- Write scripts to create, optimize, and maintain databases, tables, constraints, functions, stored procedures, indexes, and triggers
- Maintain state-of-the-art technologies and methodologies.
- Design and maintain database solutions for new and existing projects by understanding the business requirements
- Provide primary support for the organization's data repositories and will be responsible for requested SQL reports
- Work with managers of each functional area to identify and prioritize data information needs and requirements
- Create operational and financial reports to user specifications using commonly available report writing tools and queries for SQL databases
- Identify reporting requirements and writing and optimizing complex SQL queries, stored procedures, and views to extract the information, trends, or patterns contained in the data
- Validate the results of SQL queries with end users, and present the data in an intuitive and visually appealing way, which may include tables, pie charts, bar graphs, or other diagrams
- Assist with the import and export of data from third parties
- Support and troubleshoot issues
- Provides day to day support for MMPA's database environment, including administration, change control, database restores and ad-hoc support.
- Perform database administration, design and implement database strategies, improve database performance and capacity, including planning for future expansion.
- Plan, coordinate and implement database security measures, specify users and user access levels for each segment of database; modify existing databases and database management systems or direct developers and analysts to make changes.
- Develops an understanding of the company's databases and database environment.
- Assists in the development of reporting and business intelligence analyses.
- Determine logistical strategies for upgrades, major changes to existing technologies, and implementations of new technologies.
- Maintain and support Microsoft SQL 2008R2 / 2012 / 2016 Database environments.
- Maintain support and create Microsoft SSIS (SQL Server Integration Services).
- ETL (Extract Transform Load) Data to data warehouse.
- Provide final systems and application testing of developed .Net applications
- Deploy tested application updates to production environment
